Information regarding the processing of personal data

1. The personal data controller is Klub Fantastyki Druga Era Association, with its registered seat in Poznań, ul. Kaliska 22a/23 61-131 in Poznań registered in the National Court Register under no.: 0000207209.
2. We process personal data in the scope of name, address, personal ID number, address, e-mail address, telephone number. The data will be stored in the data controller's IT systems. We do not process sensitive data.P

3. Personal data will be processed in order to implement the controller's statutory tasks related to the organization of the Pyrkon Fan Convention, in the scope of the execution of the obligations that arise.
4. The management board, the employees and other volunteers of the data controller who are involved in the implementation of statutory tasks of the Club as well as entities providing the data controller with IT, legal and booking services shall be the recipients of the personal data.
5. The basis for processing is the contract concluded pursuant to art. 6 para. 1 letter b) of the GDPR and the legitimate interest of the administrator in accordance with art. 6 para 1 letter f) of the GDPR.
6. We do not transfer the personal data outside the country or to international organizations.
7. Personal data will be stored until the request for their removal is made and in the event of any dispute, until the claims related to it and the controller's obligations under public law have expired.
8. We hereby notify you about the right to access your data and the right to rectify it, delete it, limit its processing, the right to transfer data, the right to raise objections, the right to withdraw consent at any time without affecting the legality of processing, which was made on the basis of a consent before it was withdrawn.
9. We hereby notify you about the right to lodge a complaint to the supervisory body (the President of the Personal Data Protection Office), should it be recognized that the personal data processing by the controller violates the provisions of the General Data Protection Regulation of 27 April 2016 (GDPR) or other provisions regarding the processing of personal data.
10. Personal data will not be used for profiling and making automated decisions.
