Dear Sir/Madam,

Acting on behalf of the Fantasy Club Association "Druga Era" based in Poznań, we hereby inform you that, pursuant to Article 296(3) of the Industrial Property Law Act of June 30, 2000, as amended (Journal of Laws 2021, item 324), and in accordance with the guidelines of the Court of Justice of the European Union in case C-494/15, as the organizer of the Pyrkon Fantasy Festival and as an entity leasing exhibition spaces to our exhibitors, we are obligated to exercise the utmost diligence to ensure that our regulations include provisions prohibiting the sale of goods that infringe trademarks and imposing sanctions for any violations thereof.

We would like to inform you that such provisions are included in our Exhibitor Regulations:

- **In point 10:**

"The Exhibitor undertakes to display only items that are legally permitted for trade and do not infringe the intellectual property rights of third parties, in particular as understood by the Act of February 4, 1994, on Copyright and Related Rights (consolidated text: Journal of Laws 2019, item 1231) and the Act of June 30, 2000, on Industrial Property Law (Journal of Laws 2017, item 776, as amended). In the event of an infringement of the above-mentioned rights, the Exhibitor bears sole responsibility for the violation of third-party rights."

- **In point 13:**

"The Organizer may order the Exhibitor to immediately remove from the stand any elements that pose a threat to the safety of persons or property, infringe points 9, 10, 11, 14, and 15 of the Regulations, or promote hatred or the commission of a crime."

To enhance the effectiveness of protection under point 10 of the Exhibitor Regulations, we have introduced a requirement for exhibitors to submit declarations stating that their goods do not infringe third-party rights. A sample declaration is attached for your reference.

We are implementing the above-mentioned precautions to ensure that industrial property rights and copyright of third parties are protected with due diligence. We will respond decisively to any reported violations of the Regulations.

EXHIBITOR'S DECLARATION

I hereby declare that at my/our booth (name of the booth) at the Pyrkon Fantasy Festival, taking place from June 13th to June 15th, 2025, there will only be items and goods that are legally permissible for trade and do not infringe on third-party intellectual property rights, in particular as defined by the Act of February 4, 1994, on Copyright and Related Rights (Journal of Laws 2016, item 666, as amended) and the Act of June 30, 2000, on Industrial Property Law (Journal of Laws 2013, item 1410, as amended).
